The total sales volume and processing volume of the stainless steel processing services of the Group for the period from 1 October 2014 to 31 December 2014 amounted to 328,397 tonnes and 379,936 tonnes respectively representing an increase of approximately 23.1% and a decrease of approximately 7.3% respectively as compared with the same period last year.

The total sales volume and processing volume of the carbon steel processing services of the Group for the period from 1 October 2014 to 31 December 2014 amounted to 247,563 tonnes and 235,821 tonnes respectively representing an increase of approximately 139.8% and 154.2% respectively as compared with the same period last year.

The above operating information is unaudited and is based on preliminary internal information of the Group, which may differ from the figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such information.
